

ADVISER ACADEMY COURSE 1 LESSONS

Adviser Academy Course 1 provides participants with a series of self-paced lessons designed to enhance their skills and knowledge as FCCLA advisers. These lessons are available through the interactive Nearpod platform and offer a range of features such as multimedia presentations, interactive quizzes, and collaborative activities that enhance the learning experience. **Participants have until April 1 to complete all lessons in order to be considered for graduation.**

LESSON	TOPIC	DESCRIPTION
1	<i>Introduction to FCCLA and Adviser Role</i>	An introduction to FCCLA and gain an understanding of its mission and goals. They will also learn about what their role should be versus the role of their student members.
2	<i>Navigating the FCCLA Website</i>	Learn to navigate the FCCLA Website and learn what resources are available to them.
3	<i>Navigating the FCCLA Portal</i>	Learn to navigate the FCCLA Portal and learn what resources are available to them.
4	<i>The 3 R's of Membership</i>	Discover the 3 R's of membership and learn best practice on how to recruit, retain, and recognize members.
5	<i>Chapter Officers</i>	Discover ideas on how to elect and train chapter officers and then guide them on how to build a Program of Work (POW).
6	<i>Chapter Meetings</i>	Learn best practices on running chapter meetings and explore what should you do during a chapter meeting.
7	<i>The Basics of STAR Events</i>	An introduction to FCCLA STAR Events and ways to prepare your members for competition.
8	<i>The Basics of National Programs</i>	An introduction to FCCLA National Programs and dive deeper into FCCLA's Power of One National Program.
9	<i>Fundraising</i>	Discover ways to raise money for your chapter through fundraising, grants, and sponsorships.
10	<i>Preparing for Conferences</i>	An introduction to traveling in and out of state with student members.
